2011 FRACCA OUTSTANDING COMPANY AWARD

PURPOSE

The FRACCA Outstanding Company Award is to recognize corporations who have shown outstanding leadership for their service to the association, construction industry or community. The company must have been a member of a FRACCA chapter or member-at-large throughout 2010. The award will be presented annually at the FRACCA Spring Education Conference during the Awards Luncheon. A company representative must be present to accept the award.

AWARD CRITERIA

The company should describe in detail how they, as a company, have helped to better the industry, community or our association. Any printed materials on programs developed, recognition by other organizations, newspaper articles, etc. should be submitted as evidence. A brochure on the company must accompany the nomination form that outlines the company and its services. **Companies may self-nominate or nominate others.**

PURPOSE

FRACCA CHAPTER AWARDS

PURPOSE

The FRACCA Awards are to recognize the affiliated chapters of FRACCA for their contribution to our industry. The awards will be presented annually at the FRACCA Spring Education Conference during the Awards Luncheon. A chapter representative must be present to accept the award.

AWARD CRITERIA

Chapter Award of Excellence:

The Chapter must submit evidence of activity in each of the categories that apply on the attached list. If there is no activity in a specific category, explain reasons why. The Chapter must have been a member of FRACCA throughout 2010.

Chapter Innovation Award:

The Chapter must describe in detail a program that was developed and implemented during the last 24 months that has had a positive impact on the HVAC industry or local community or chapter. Chapter must provide all printed information on the program to include as appropriate: program announcements, press releases, pictures, flyers, results of program, cost of program, member participation, etc.

Submission deadline is FRIDAY, FEBRUARY 15, 2011.

CHAPTER AWARD OF EXCELLENCE

FRACCA chapter must submit evidence of the following along with the completed nomination form:

1. Holds regular scheduled elections of officers and directors.
2. Holds scheduled Board Meetings and maintains minutes of those meetings.
3. Provides regular communication with its members including activities of FRACCA.
4. Holds regular scheduled membership meetings / programs.
5. Has appointed representative and alternate to FRACCA Board of Directors.
6. Has paid FRACCA membership dues on a timely basis during calendar year of the award.
7. Provides FRACCA with updated membership list on a quarterly basis.
8. Provides FRACCA with newsworthy articles for publication.
9. Supports, promotes or operates a training or apprenticeship program.
10. Provides educational programs for the chapter members.
11. Supports FRACCA legislative efforts.
12. Active in local advocacy issues.
13. Provides no less than quarterly, financial reports to Board and files annual tax report to IRS and state as required.
14. Submits all required state and federal reports.
15. Membership retention was _____% (Provide %) during the calendar year prior to the award.
